3. Confirmation of agenda

4. Minutes of the previous meeting

The minutes of the previous meeting held on Friday 1 May 2015 were accepted as a true and accurate record of the meeting.

5. Business arising from the previous meeting

All action items from the previous meeting have been addressed.

6. Bullying in the Workplace

Ged Kearney, ACTU President gave a presentation on the issues of bullying in the workplace, domestic violence and return to work. Information was provided about current legislation and work being undertaken by the Australian Council of Trade Unions in relation to these issues. The union movement takes great interest, and participates in, those issues that affect society, not just those found in the work environment. Work plays an important role in providing answers to some complex societal problems.

7. Chief Nurse and Midwifery Officer update

This update was provided by Debra Thoms, who has just commenced in the position, taking over from Dr Rosemary Bryant AO, who retired in June 2015. Deb now has a position on the board of the National Health and Medical Research Council as a permanent observer. She is working with a range of people across the Department of Health. Deb will be writing to the members of the Nursing and Midwifery Stakeholder Reference Group to take part in strategic debate on nursing and midwifery. She invited feedback from CoNNO on any issues relating to nursing and midwifery to debra.thoms@health.gov.au.



8. Department of Health Update

An update was provided by Tarja Saastamoinen, Assistant Secretary and Karen Cook, Director Innovation and Reform, Health Workforce Reform Branch.

Issues discussed:

- The Skilled Occupation List is open for review and will close 31 October 2015.
- Looking at Health Workforce Australia data projections and continuing to work with this data.
- New Nursing and Midwifery Education Advisory Network (NMEAN) to be set up.
- Department is holding national workshops for consultation on the development of a National Chronic Conditions Strategic Framework in October and November.
- Federal Government Ministry changes include: Ageing and Aged Care back in the Health portfolio; Minister for Health, Sussan Ley; Minister for Ageing and Aged Care, Ken Wyatt; Minister for Rural Health, Fiona Nash.
- Department of Social Services to undertake a Nanny Pilot Project. This programme will provide \$246 million over two years to support families who struggle to access child care services when working, studying or training, by providing fee assistance to eligible families using a nanny in the family home. Care will be subsidised for up to 50 hours per child per week, for around 10,000 children, and delivered by approximately 4,000 nannies. Applications are now open for families who wish to participate in the pilot and will close 30 October 2015. For more information please visit the Nanny Pilot Programme website.

9. Nursing and Midwifery Board of Australia (NMBA) Update

An update was provided by Tanya Vogt, Executive Officer.

Issues discussed:

- Endorsement as a nurse practitioner registration standard and Registration standard for endorsement for scheduled medicines for midwives are awaiting Ministerial approval.
- Registration standards for Recency of practice, Professional Indemnity Insurance and Continuing Professional Development have been approved by Ministers. NMBA will be working on the rollout which will include workshops and roadshows.
- The NMBA have undertaken preliminary consultation on the Registration standard for endorsement for scheduled medicines registered nurses (rural and isolated practice). A public consultation will be conducted later this month.
- The NMBA has undertaken to do some work on nurse prescribing. They are looking at international models, models that may work in Australia and considering the Board's role in relation to prescribing.
- EN Standards for Practice -will be launched at the NENA conference on 21 October 2015.
- RN Standards for Practice project is in the final stages of observations, with the NMBA to consider the final draft in November 2015.
- Review of the Codes of Professional Conduct, Codes of Ethics and Professional Boundaries documents is scheduled for early in 2016.
- The Board has made an announcement in the last week about the new National Health Impairment Scheme for nurses and midwives.
- Four new Board members are: Chris Helms (ACT), Nicola Giovonetti (WA community member),
 Annette Symes (NSW), Jennifer Woods (WA).
- Midwifery Standards for Practice the call for tenders is scheduled for early 2016.



10. Australian Nursing and Midwifery Accreditation Council (ANMAC) update

An update was provided by Fiona Stoker, Chief Executive Officer.

Issues discussed:

- ANMAC is updating their website to engage and communicate with stakeholders and seek feedback from nurses and midwives via the website.
- ANMAC Board meet every two months with a communique posted after each meeting.
- Deb Thoms is joining the ANMAC Board as the Commonwealth Chief Nurse and Midwifery Officer and Associate Professor Susan Pearce, as the jurisdictional representative.
- Currently finalising the Re-entry to Register Midwife Accreditation Standards
- The Nurse Practitioner Accreditation Standards and the Midwife Scheduled Medicines Accreditation Standards have been approved and released on the ANMAC website.
- The first consultation paper for the review of the Enrolled Nurse Accreditation Standards is currently open for public consultation.

11. National E-Health Transition Authority (NEHTA)

An update was provided by Heather McDonald on the Personally Controlled Electronic Health Record (PCEHR). A total of 2,409,214 Australians have registered for PCEHR with 5,200 GP practices engaged. PCEHR is still an 'opt in' record.

NEHTA is transitioning to the new body, the Australian Commission on E-Health (ACEH), which will commence operations next year. The Federal Government has made a commitment on e-Health for a further four years. The PCEHR will become the new MyHealth Record. Pilot sites for the MyHealth Record have been selected. The MyHealth Record will be 'opt out' and is GP software compatible.

12. Nursing Leadership Panel Discussion

The panel consisted of Deb Thoms, Commonwealth Chief Nurse and Midwifery Officer; Tanya Vogt, Nursing and Midwifery Board of Australia Executive Officer; Fiona Stoker, Australian Nursing and Midwifery Accreditation Council Chief Executive Officer; and Rhonda Griffiths, CoNNO representative for the Council of Deans of Nursing and Midwifery.

The panel discussed a wide range of issues critical to the nursing and midwifery professions.

13. Council Report

An update was given by Julianne Bryce and Christopher Cliffe.

New CoNNO Council members are Marian Linnane from Nursing Informatics Australia and Sharon Temby from the Australian Dermatology Nurses Association. Outgoing long term member Theresa Swanson was thanked for her input to both CoNNO and Council over many years.

Funding for CoNNO has been secured for another two years from the Commonwealth Department of Health.

Conno Council has developed a brief overview and an information sheet on Conno for Conno member organisations and key stakeholders. It is anticipated these documents will be useful to raise awareness about Conno amongst the members of our member organisations and to a broader group of health stakeholders. These documents have been sent to Conno member organisations and will also be sent to key stakeholders.
